2023 MUNICIPAL ELECTION IMPORTANT DATES AND REMINDERS

Voter Registration Deadline

The Voter Registration Deadline for the Municipal Election is Friday, October 13, 2023 at 5:00 pm.

Sample Ballots

Sample Ballots for each Town are available in our office and on our website.

Absentee Voting

The Town of Windsor is the only Municipality that allows Absentee Voting for their Town Residents. Absentee by mail voting for The Town of Windsor Residents begins on Friday October 6th. Town of Windsor Residents who wish to vote by Absentee Mail must complete an Absentee Ballot Request Form.

One Stop Early Voting begins for Windsor residents on Thursday October 19th and ends Saturday November 4th. One Stop Early Voting hours are 8:30 am-5:00 pm on weekdays and on Saturday, November 4th from 8:00 am-3:00 pm.

Municipal Election

The Municipal Election is Tuesday, November 7th. Polls are open from 6:30 am -7:30 pm.

Municipal Election: Canvass

Canvass for the Municipal Election is Friday, November 17th at 11:00 am. This is the date when the Election Results are Finalized.

Voter Photo ID

As a reminder, beginning with the 2023 Municipal Election voters will have to show an Acceptable Photo ID to Vote.



WHAT PHOTO ID CAN I USE?

Any of the following that is, **unexpired or expired for one year or less:**

- North Carolina Driver's License
- U.S. Passport/U.S. Passport Card
- State ID ("non-operator ID"), from the NCDMV
- NC Voter Photo ID card, issued by a county board of elections (available soon)
- College/university student ID approved by NCSBE
- Charter school employee ID approved by NCSBE
- State/local government employee ID approved by NCSBE

Any of the following, **regardless of whether the ID contains an expiration or issuance date:**

- Military or veteran ID card issued by the U.S. government
- Tribal enrollment card issued by a State or federally recognized tribe
- ID card issued by a U.S. government agency or the State of NC for a public assistance program

The Town of Windsor Residents who choose to request an Absentee by Mail Ballot, a Photo Copy of their Photo ID must be included with their returned balloting materials. Instructions will be provided.

Although Voter Photo ID is required for voting, no voter will be turned away from the Polls. Voters without an Acceptable Voter ID will be given a Photo ID Exception form to indicate the reason they do not have an Acceptable Photo ID.

Photo ID Exceptions include the following:

EXCEPTION 1: REASONABLE IMPEDIMENT

I suffer from a reasonable impediment, selected below, that prevents me from including a copy of photo ID.
